VOLUNTEER CONFIDENTIALITY AGREEMENT

I understand that as a volunteer of the Flathead County Agency on Aging (AOA) I must keep confidential information I may learn about AOA clients in the course of my volunteer duties.

The use or disclosure of any information concerning a client, or for any purpose not directly related to serving the client, is prohibited, except on written consent of the client, or the court-appointed guardian of a client.

Confidential information is defined as personal information which federal or state legal authorities or regulations protect from general public access and release. It includes but is not limited to the name, social security number, driver's license number, street and postal addresses, phone number, email address, medical data, protected health information as defined for purposes of the federal Health Insurance Portability and Accountability Act (HIPAA) and Health Information for Economic and Clinical Health Act (HITECH), individual eligibility information, individual case information, programmatic payment and benefit information and information obtained from the IRS or other third parties that is protected and confidential.

Any unauthorized disclosure or use of confidential personal information by a volunteer must be reported to AOA staff immediately so steps can be taken to retrieve such information and prevent further unauthorized disclosure or use.

RE: Volunteer Safety and Liability Protection

WELCOME! Please accept our heart-felt appreciation for volunteering to share your time and talents with Flathead County.

There are a few insurance and safety items that you need to be aware of as you embark on your volunteerism journey for the County.

1. The County's "General Liability" insurance policy allows for your defense in the extremely rare chance that an accident occurs as a result of your negligence while volunteering for the County.
2. The County's "Worker Compensation" insurance policy does not provide coverage for you in the extremely rare chance that you may be injured while volunteering for the County.
 - The County department for which you are volunteering has chosen to include your position under an insurance policy allowing up to \$50,000 accident medical reimbursement.
3. If you are driving a Flathead County-owned automobile, you are protected as an insured under the County's automobile liability insurance. If you are driving your own vehicle, you must rely on your own automobile insurance for any and all damages incurred in an accident. You will be asked to provide proof of automobile liability coverage on your vehicle before driving your own personal automobile on behalf of Flathead County.
4. In certain situations, the County will perform a reference and/or background check.
